### New guidelines for public ancillary funds

Private Ancillary Funds and Public Ancillary Funds are Deductible Gift Recipient ('DGR') funds which are entitled to receive donations that are tax deductible, essentially for the purpose of distributing to other DGRs, and which cannot engage in any other activities.

Recent changes to the Taxation Administration Act 1953 provides that the Minister must formulate guidelines for public ancillary funds and their trustees for DGR purposes.
